Limit 2 entries per wrestler, 1 per age division. Second entry \$15 (email for 2nd entry info). Missed weight will result in bump up fee of \$10. We reserve the right to combine weight classes.

Awards: Champion rings and holiday medals awarded 1st place. Holiday medals to 2nd-4th place.
