Weigh Ins: 1/19/24, 6:00 AM – 8:00 AM @ BCHS (scratch meeting to follow) **(11lb allowance)**

Must weigh in a singlet or shorts and t-shirt! Wrestling begins after scratch meeting.

Rules: Wrestlers MUST enter age group according to age as of January 1st, 2025. Double Elimination. Wrestlers will wrestle (3) 1-minute periods. Scholastic rules apply with sudden death overtime. Limit (2) entries per wrestler, IN DIFFERENT AGE BRACKETS. We reserve the right to combine weight classes. \$10 bump up fee. Proof of age (if challenged). Every effort will be made to separate wrestlers from the same team. Registered officials used – their decision is final. **BELLIGERENT BEHAVIOR WILL NOT BE TOLERATED.**

Awards: Individual awards are given to 1st, 2nd, 3rd, and 4th place finishers in each weight class.

Girls Division: All female wrestlers are encouraged to wrestle in this division. We will use the Madison System to create bouts. Girls in this division will wrestle within 10% of their weight. Age brackets for all divisions are posted below. Girls are permitted to wrestle in regular open tournaments and may double enter.
